# CHRONOLOGY

# BRUCE W. TAYLOR • PHOTOGRAPHER

1949	Born in Columbus, Ohio.
1951	Moved with parents to Maryland as father accepted a job with the US Army as a microbiologist at Camp Detrick.
1965 - 1968	Was a volunteer firefighter for local town. Training to become a mid-shift pump operator.
1967	Graduated from high school. Interested in photography and had film and prints processed at a local camera store. Was using medium format (6cm x 6cm and 6cm x 7 cm) camera's at this time. Draft was very close, "Uncle Sam" was even closer.
1968 - 1974	Joined the US Air Force. Served four years of active duty, trained and specialized as a bomb technician. Served one year in Viet Nam and two years with the Ready Reserve's (Worldwide) also as a bomb technician.
1970 - 1972	While in the Air Force and stationed in Florida, learned to process photographic film and make photographic prints at an on base (hobby) darkroom in spare time.
1972 - 1974	Came to Atlanta, Georgia for a two year basic photography course through a liberal arts college. Became interested in art and architecture through art history classes. Graduated with an AA Degree in Photography.
1974 - 1976	Landed a job in photogrammetry for a civil engineering company. Worked with large format aerial films, glass plates, large photographic prints, and photographic mosaics.
1976	Self-employed as a commercial architectural photographer for twelve years.
1977	Started photographing Atlanta's subway system on the East line. First contract East Lake Station and Line. Worked on this subway system part time for ten (10) years. Book made in 2018.
1989	Architectural field came to an end (US economy). Put photographic equipment into storage, rented a darkroom and lab for color and black films and prints. Still continued photographic work. Entered exhibitions and showed photographic work throughout the US. Received local city, county, and state individual artist grants. Got married.
1991	Daughter was born.
about 1995	Photographic items became harder to get. Digital imaging came into vogue.
2000	First digital photographic project: "New Vending Avenue." Compiled using multiple photographic negatives (4" x 5" and 6 x 7 cm) with photo software. Digital pigment prints made.
2018	First self-published book "Atlanta Down Under - The Building of Atlanta's Subway System." Introduction by Doug Most - author of "The Race Underground - Boston, New York," and the American Experience (PBS) movie of the same. A solo exhibition followed at the Sycamore Place Gallery, Decatur, Georgia.
2020	Started printing additional pigment prints of his work during our world wide pandemic.
2021	Was included in the exhibition: "Revelations II: Recent Photography Acquisitions" at The Ogden Museum of Southern Art, in New Orleans, L.A. Curator: Mr. Richard McCabe. Exhibition was held for seven months. Revelations II followed "The Southern Photographers of the New Generation."
2023	In December, changed name from Bruce W. Taylor Photographer to Bruce W. Taylor Photographic Archives.
